<u>Approval of Agenda</u>: A motion was made by Councilman Warmbrodt and seconded by Councilman Poague to approve the agenda and to include an executive session at the request of Solicitor Thomas. Motion carried unanimously.

<u>Minutes</u>: A motion was made by Councilman DePanfilis and seconded by Councilman Cherry to approve the minutes from the regular meeting on October 10, 2023. Motion carried unanimously.

A motion was made by Councilman Poague and seconded by Councilman Cherry to approve the minutes from the special meeting held on November 1, 2023. Motion carried unanimously.

<u>Guests & Public Comment</u>: St. Marys Ambulance Service gave an extensive presentation to Council about the difficulties facing EMS services at this time particularly a lack of funding. They are requesting that the Council consider tax millage to help with funding as Johnsonburg's EMS provider. A lengthy discussion was held with many questions presented by Council and answered by the representatives from the ambulance service.

Augustine Oglesby presented her concerns to council about problems in her neighborhood, 400 block of Second Ave., including a sunken storm drain and junk in front of houses. A discussion was held on the difficulty of code enforcement procedures.

Monthly Reports

<u>Mayor:</u> Mayor Paget reported that the Halloween town activities were a success. He commended the Veteran's Day assembly at the Johnsonburg Area High School and updated Council on Johnsonburg Community Trust projects.

Police: Monthly report is on file.

A motion was made by Councilman DeAngelo and seconded by Councilman Cherry to accept, with regret, the resignation of Zach Shelley as a part-time police officer. Motion carried unanimously.

Fire Chief: Monthly report is on file.

<u>Superintendent</u>: Monthly report is on file.

<u>Council Committees</u>: The public works committee met to review the storm sewer work on Julia St., the hotel demolition cleanup on E Center St., and look at the street light conditions.

<u>Finance & Bills for Payment</u>: President Maletto read the borough's account balances and the bills. This month's bills include General Fund - \$6,807.37, Community Center Fund - \$9,218.24, Highway Aid Fund - \$10,719.23, and Community Improvement Fund - \$1,575.00. A motion was made by Councilman Poague and seconded by Councilman Warmbrodt to pay the bills as presented and to accept the finance report. Motion carried unanimously.

Solicitor: Solicitor Thomas requested an executive to discuss litigation.

<u>Engineer & Code Enforcement Report</u>: Monthly report is on file. Engineer Ryan Miller updated Council on the status of the Julia St. Stormwater Project, the Johnsonburg Hotel Site Clean Up Project, the Johnsonburg Community Center handicap parking paving project, and the Johnsonburg Community Center heating/ac project.

<u>Municipal Authority</u>: Minutes are on file. Councilman Poague gave an update on the Spring St paving which is being done by the authority after a water leak washed out the roadway. The pavers will wait until spring to put on the topcoat.

Recreation Board: Minutes and reports are on file.

<u>Old Business</u>: 1. After a brief discussion, it was decided to advertise again for the part-time street department employee in 2024.

2. A motion was made by Councilman DePanfilis and seconded by Councilman Poague carry over the police department officers' vacation and personal days from 2023 through 2024. Motion carried unanimously.

<u>New Business</u>: 1. A motion was made by Councilman DePanfilis and seconded by Councilman DeAngleo to adopt Resolution 08-2023 which adopts the Elk County Hazard Mitigation Plan. Motion carried unanimously.

- 2. After a discussion on the repository bid for three properties on Harrison Ave., the Council did not approve the offer from Adrian Bevacqua of all three properties for \$500.
- 3. A motion was made by Councilman DePanfilis and seconded by Councilman Poague to approve the purchase of a 2024 F150 police vehicle from Tri Star Motors for \$63,307.85. Motion carried unanimously.
- 4. A motion was made by Councilman Imbrogno and seconded by Councilman DePanfilis to accept the high bid of \$2,556.00 from Adam Tegano for the borough's 2010 Ford Crown Vic. Motion carried unanimously.

<u>Public Comment</u>: Dawn Karellas, Johnsonburg Community Trust board member, reported that Epic Heating & Cooling has finished installing heating and a/c in their first bay of the brick block building on Market St.

More discussion was held on the St. Marys Ambulance Services presentation.

A motion was made by Councilman Warmbrodt and seconded by Councilman Cherry to move into executive session to discuss litigation at 6:13 p.m. Motion carried unanimously.

A motion was made by Councilman DeAngelo and seconded by Councilman Warmbrodt to return to <u>regular session</u> at 6:27 p.m. Motion carried unanimously.

President Maletto stated that, during executive session, litigation was discussed but no action was taken.

Solicitor Thomas made a public statement stating that a settlement was reached in the borough's lawsuit involving Angel Perez Jr. Further information can be obtained through a Right To Know Request.

Adjournment: A motion was made by Councilman Poague and seconded by Councilman DeAngelo to adjourn the meeting at 6:28 p.m. Motion carried unanimously.

Engineer's Report - December 11, 2023 Johnsonburg Borough Council Meeting

The following is a summary of work performed over the last month, including updates on current project status, provided herein for your review:

Engineering Services

- The Julia Street Stormwater Project has been completed and is working well. The sediment trap was installed and new grass had already begun to grow over the disturbed lot. Final inspections and project closeout have been completed with the County Planning Office.
- The Johnsonburg Hotel demolition cleanup has been completed. No parking signs have been
 posted and mostly obeyed. Final inspection and project closeout have been completed with the
 County Planning Office.
- St. Marys Paving and Hilltop Masonry have completed the JCC rear driveway project. All debris
 has been cleared and the Recreation Board is working on getting the accessible parking space repainted. We continue to work to get the dumpster fence section ordered and replaced.
- We completed and submitted the three (3) Local Share Account (LSA) grant applications for a new street sweeper and the West End Flood Control and Armstrong Theater Redevelopment Projects. The final request for the West End Flood Control Project was just shy of \$1 million dollars and covers the installation of the buried storage cells and replacement of the existing culvert. Letters of support from the County and our State legislators were included.
- We met with Epic Heating & Cooling to discuss the next phase of the JCC Heating Upgrade Project. A change in the scope of work has been made and mini-split units will now be installed in each of the three (3) rooms on the second floor. Funding for this project was made possible from a recent grant received from the Mee Foundation. The work is anticipated to be completed over the next couple of weeks.
- We assisted with a recent grant request from the Palumbo Foundation for the preventative
 maintenance repairs to the exterior of the Johnsonburg Community Center. The requested funds
 would be used to re-point the brick façade and refinish the windows. Estimates were gathered
 from local contractors to assist with the request.
- Nittany Energy's expansion of the former Old Brickyard gas station has begun. We continue to work with them and their engineer on the required stormwater management plans and report.
- We continue to work with the Elk County Planning Office on additional PHARE funding for slum and blight demolitions. The remaining vacant/abandoned structures in the First Avenue/Bergen Street area have been identified based on the funding that may be available.



Code Enforcement

- The former repository property located at 307 High Street was recently inspected and as a result the previous "uninhabitable" posting has been removed. The new owner has been renovating the house with the intent to rent it out. The County has been notified of the posting removal and a request has been made to return the parcel to the tax rolls.
- Uninhabitable notices were posted as a result of notification from the Water Authority of water service being shut off. We continue to work together with the JMA when service to these properties is shut off.
- Residents are reminded that garbage may not be placed along curbs more than 24 hours prior to pick up. An increase in the number of occurrences has been observed recently. This is not only a public nuisance but can become a hazard if and when snow plowing operations start.
- As snow season approaches, residents are reminded that shoveled/plowed snow is not permitted to block public sidewalks, including entrances at intersections and ends of driveways.
